Application for use of archival documents concerning the Nobel Prizes in Physics and Chemistry

Documents of the Nobel Archives older than 50 years were first opened for scholarly research by an amendment to the basic statutes of the Nobel Foundation in 1974. Previously the archives were closed. According to the statutes of the Nobel Foundation §10, third paragraph: *A prize-awarding body may, however, after due consideration in each individual case. permit access to material which formed the basis for the evaluation and decision concerning a prize, for purposes of research in intellectual history. Such permission may not, however, be granted until at least 50 years have elapsed after the date on which the decision was made.* The statutes of the Royal Swedish Academy of Sciences governing the Nobel archives further specify: *In considering an application under §10, paragraph 3 of the Statues of the Nobel Foundation, the rule shall be that material relating to the research work of a named person may not be released during that person's lifetime. If an application is made for the release of material which includes a special investigation or opinion by a named person who is still alive, the material may not be released without the consent of the person concerned*.

These rules concern documents in the Nobel archives of the Royal Swedish Academy of Sciences older than fifty years, which relate to the decisions to award the Nobel prizes in physics and chemistry. At the beginning of each year material relating to the prize-decision of 50 years earlier is released, i.e. in the beginning of 2023 the documents of 1972 are released and so on. These documents consist mainly of various minutes, scientific evaluations of different candidates and letters of nomination. N.B! With the exception of the last kind of document, the main part of the archival material is in Swedish.

The Nobel Archives relating to the prizes in physics and chemistry is managed by the Center for History of Science at the Royal Swedish Academy of Sciences, Stockholm. Applications are to be addressed to this institution. The archive is open only to individual researchers after decision and approval by the Center in each single case according to the statues exemplified above. Normally only *bona fide* historians of science are granted access. The conditions of use of the documents are apparent from the rules listed on the third page of this form.
